- Six sites: Appalachian, Cold Springs,

- Available to all Circuit Courts and the Parole Board
- Probation cases, parole cases, and technical violators may qualify
- Must be physically able to participate in program requirements
- Must be eligible and accepted prior to sentencing

Being prescribed mental health medications does not necessarily preclude a potential participant from being considered for CCAP.



CCAP REFERRAL UNIT

The CCAP Referral Unit serves as the interface between P&P Offices and CCAP facilities to evaluate probationers/parolees for eligibility into CCAP along with scheduling them for intake. Once the probationer/parolee arrives at an intake site, they will be assessed to determine programming needs in order to guide placement to the appropriate CCAP facility.
